Joel Thompson – Mr. Thompson stated that he had told Selectwoman Guelcher at the last meeting that he would not be interested in the search committee for an administrative Assistant he would like to know the details and purpose of this committee. Chairman Bailey explained that this committee would take the resumes and review and then suggest to the Select Board who to interview. Mr. Thompson would like to be on the committee. Mr. Thompson also wants to ask the Selectman Hopkins to resign from his position as a Selectman because of his misuse of power when Scott Parsons from Uhaul came to retrieve the stolen trailer. Mr. Thompson states that Selectman Hopkins stated last week that the Chief of Police and also the other 2 police officers were present when Selectman Hopkins told Scott Parsons that he was a Selectman in the Town. Mr. Thompson spoke with Scott Parsons and he stated that was not how it happened at all. Mr. Parsons told Mr. Thompson that Selectman Hopkins stated to him that he was a Selectman in Town, that he knew the Chief of Police, and that he was in the Military. Chairman Bailey stated that last week when Mr. Thompson had asked the two senior Selectmen to ask the junior Selectman to step down that they didn't hear him. Chairman Bailey stated that this is all hear say and that Mr. Parson's would need to come into the see the Selectmen and make a complaint. Mr.


Thompson stated that Mr. Parson's did say he would come in if need be. Mr. Thompson asked about the misuse of plates. Chairman Bailey stated that a complaint would have to be filed with the police.

Chairman Bailey asks how many people should be on the search committee for the Administrative Assistant position. Chairman Bailey was thinking 5 people on the committee. Mr. H. Drugg asked what is the position going to be full-time, 2 part-time. Chairman Bailey stated that will come from recommendation of the search committee. Chairman Bailey stated that there are 7 volunteers on the list. Chairman Bailey states that Dick Thackston and Selectman Hopkins should not both be on the committee. Chairman Bailey also stated that there shouldn't be 2 budget committee members on the search committee. Chairman Bailey has two people that haven't volunteered that he thinks should be considered, Ed Oakes and Alissa Fox. Mrs. Fox stated that it depends who is on the committee. Mr. Stearns asked how many meetings do we think this will entail. Chairman Bailey stated three or four meetings. Mrs. Fox asked if the committee would be doing the interviewing and then recommending to the Select Board or is the committee just looking at the resumes. Chairman Bailey stated that the Select Board will be doing the interviews. Chairman Bailey **MOVED** to appoint Ben Drugg, Sheryl White, Kyle Smith, Tom Mattson, Joel Thompson, Jody McDermott and Curtis Hopkins to the search committee **SECOND** Selectman Hopkins **VOTE** unanimous
