15 agreement to perform code enforcement services for the Town as an independent contractor.

18 Selectman Thackston proposed using the services of a lady to assist the Town Hall staff with
19 organizing files and records. The other Board members agreed that it could help the staff
20 within the Selectmen's Office.

22 **MOTION** to authorize Selectman Thackston to approach Ms. Amanda Norcross to assist the
23 Troy Town Hall staff with organizational systems and approaches, Selectman Hopkins,
24 **SECOND** by Selectman Thackston. **VOTES: 3-0-0.**

26 Mike Leclerc, chair of the Water/Sewer Commission joined the meeting at 7:06 P.M. The
27 Board discussed the purchase of a new truck for the Water and Sewer departments. Mr.
28 Leclerc stated the Water and Sewer departments were hoping to phase out their EIN and
29 continue with merging functions with the Town instead of operating independently. The
30 Board stated it may be in their best interest to utilize the W/S EIN for the purposes of
31 purchasing this truck right now due to the ongoing litigation.


