- 1 Call to Order
- 2 Chairman Sawyer called the meeting to order at **7:05pm**.
- 3 Roster, Officers, Appointments
- 4 Selectman Hopkins **NOMINATED** Chairman Sawyer to be the chairperson, **SECOND** by Mr.
- 5 Smith. All members of the board voted in favor of this nomination.
- 6 Chairman Sawyer NOMINATED Mr. Hopkins to be the Secretary of the Planning Board,
- 7 **SECOND** by Selectman Hopkins. All members of the board voted in favor of this nomination.
- 8 Chairman Sawyer tabled the nomination of the Vice Chair of the Planning Board until a later date.
- 9 Chairman Sawyer **NOMINATED** Mr. Collins to be a member of the planning board for a one-
- year term, **SECOND** by Mr. Smith. All members of the board voted in favor of this nomination.

- 12 The Planning Board received a newsletter from the Southwest Region Planning Commission that
- was read out by Mr. Sawyer.
- Lot line adjustment application from Kirsten Tandy relative to Map 18, Lots 223 and 224,
- 15 located at 18 and 20 South Main Street.
- 16 The Planning Board went through the subdivision checklist and discussed. Mr. Sawyer explained
- that since both of the lots are none conforming the Planning Board can not approve it with out a
- variance approval from the Zoning Board.
- 19 MOTION to accept the Lot Line Adjustment as complete, Mr. Underwood. SECOND by Mr.
- 20 Sawyer. All members of the board voted in favor.
- 21 The next step for the applicant is to bring this to the Zoning Board. This application will stay on
- 22 the Planning Board agenda until it is heard by the Zoning Board.

- 25 to do. The Planning Board discussed these plans and what the next step for Mr. Sabolevski will
