1 *Chairman Chasse called the meeting to order at 5:04 p.m.*

3 **NON-PUBLIC SESSION, NH RSA 91-A:II (I):**

4 **MOTION** by Selectman Thackston to enter Non-Public Session under NH RSA 91-A:2 (I)

5 **SECOND** by Selectman Hopkins **By roll call vote: Chasse, Yes; Hopkins, Yes; Thackston,**

8 The Board entered Non-Public Session to discuss a legal matter at 5:05 p.m.

10 **MOTION** to exit Non-Public Session, Selectman Thackston **SECOND** by Selectman Hopkins.

11 **By roll call vote: Chasse, Yes; Hopkins, Yes; Thackston, Yes.**

13 The Board exited Non-Public Session at 6:00 p.m.

15 During the Non-Public Session, the Board discussed a legal matter being brought against the Town
16 of Troy. They discussed Legal Counsel's advice. The Board discussed answers to each of the
17 questions brought against the Town.

19 **MOTION** to authorize the Town Administrator to submit the Board of Selectmen's answers, as
20 edited, in this meeting, to Town Counsel, Selectman Hopkins, **SECOND** by Selectman Thackston.
21 **VOTES: 3-0-0.**

23 The Board of Selectmen hopes for a fair outcome from the legal case against the Town and is
24 focused on working the responses out with the Water & Sewer Commissioners.

26 There was discussion regarding amount for the 2024 Legal Budget line, perhaps at \$50,000.

28 The Board reviewed a request for a Yard Sale permit, October 28 at 40 North Main Street.

29 **MOTION** to approve the permit request, Selectman Thackston, **SECOND** by Selectman Hopkins.
30 **VOTES: 3-0-0.**

32 A staff holiday party was discussed. **MOTION** to authorize the Selectmen's office to schedule a
33 holiday party for staff in the upcoming season, in the best interest of morale, Selectman Thackston,
34 **SECOND** by Selectman Hopkins. **VOTES: 3-0-0.**

36 The Town Administrator notified the Board she will be away for a few days in the first full week
37 of November.

39 Changes to the Town's bank were discussed.

42 **MOTION** to adjourn, Selectman Hopkins, **SECOND** by Selectman Thackston. **VOTES: 3-0-0.**
