9 **SECOND** by Selectman Hopkins. **Roll Call Vote: Chasse, Yes; Hopkins, Yes;**

12 The Board of Selectmen entered Non-Public Session at 7:03 p.m.

14 Cemetery Trustees Matthew Whooley and Diane Lepisto joined Cemetery Laborer Skip
15 Mason and applicant Joseph Morrissey. Mr. Morrissey applied for the part-time Cemetery
16 position with the goal of eventually taking over for Skip upon his retirement.

18 **MOTION** to hire applicant Joseph Morrissey as a part-time cemetery employee at the rate of
19 \$14.29 per hour, Selectman Thackston, **SECOND** by Selectman Hopkins. **VOTES: 3-0-0.**

39 violations on his property and potential issues with his town residency. He left the meeting at
40 10:14.

42 Matthew Whooley joined the meeting at 10:14 p.m. He notified the Town of a possible RSA
43 violation (95:1) of a committee within Town. He indicated a desire to attempt to address the
44 issue internally at a future committee meeting but would follow-up with the Selectmen if
45 need be. He left the meeting at 10:19 p.m.

47 The Board and Town Administrator discussed a potential personnel issue, the tax deeding of
48 a town property, and a possible contractual dispute.

52 **Thackston, Yes.**


