15 The Board reviewed a list of on-going code enforcement cases, including two that have gone to
16 the Town Attorney previously. The Town Administrator will be working with the new Code
17 Enforcement Officer regarding these and will provide the Board with an update on them.

19 Police Chief Dave Ellis discussed the health and code reports done recently regarding a tax
20 deeded property. The Board agreed to provide the reports to the previous owner once the sale
21 goes through. The Town Administrator will provide the Police Chief/Health Officer with the
22 code report, as well as a recent letter sent to a property owner regarding a code violation in
23 Town.

25 **MOTION** to provide both the health and code reports to the previous owner once the deeded
26 property is sold back, Selectman Thackston, **SECOND** by Selectman Hopkins. **VOTES: 3-0-0.**

28 **MOTION** to exit non-public session under RSA 91-A:3, II (C), Selectman Thackston,
29 **SECOND** by Selectman Hopkins. **Roll Call Vote: Chasse, Yes; Hopkins, Yes; Thackston,**
30 **Yes.**
