Meeting Minutes, October 23, 2023**

- 1 I. Chairman Drugg called the meeting to order at 6:00pm.
- 2 II. Approve Minutes: MOTION to approve the meeting minutes of October 16, 2023 as  
3 written, Mr. Hopkins. SECOND by Ms. Hummel. All members of the committee voted in  
4 favor of this motion.

15 Chasse. SECOND by Mr. Hopkins.  
16 Selectmen Chasse withdrew this motion, the Committee did not enter nonpublic.
- 17 The Budget Committee discussed with Ms. Momaney, Warrant Article 14 –  
18 Expendable Trust Funds Deposits that was approved during last year's Town Meeting.  
19 The Committee explained that the Warrant article was put into place to deposit money  
20 not to expend money and the money that was put in place was supposed to be used for  
21 replacing lights and painting the Gay Kimball Library these renovations have partially  
22 been done throughout 2023. Ms. Momaney explained that only the painting has  
23 partially been paid for, and the other renovations may not be done until 2024.
- 24 IV. Old Business: There was no old business to discuss.
- 25 V. Public Comment: There were no public comments.

26 VI. Adjournment: MOTION to adjourn the meeting, Mr. Thackston, SECOND by Ms. Chasse.
